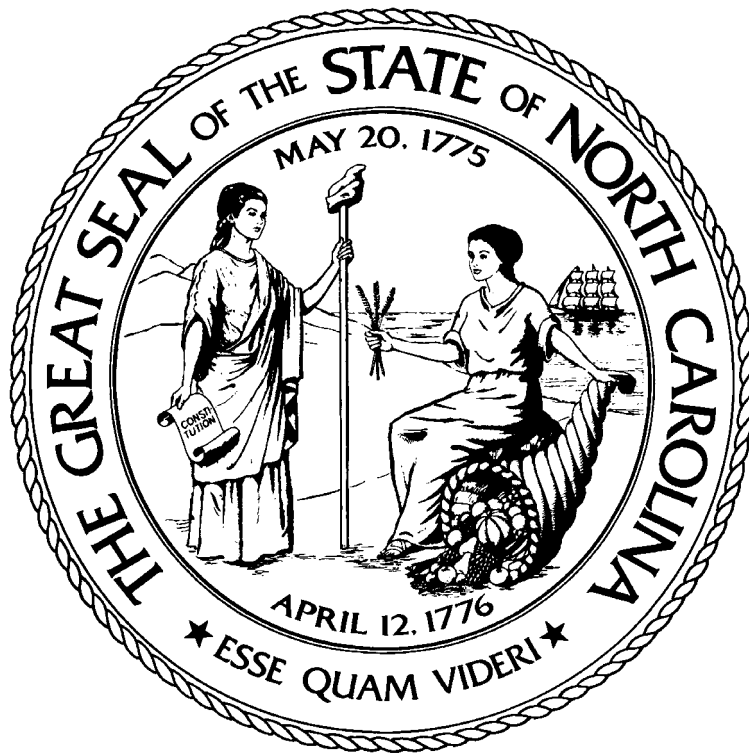

Please contact us if you have questions or if you would like more detailed information. We are committed to providing you and the State with the most reliable and timely financial and economic information possible.

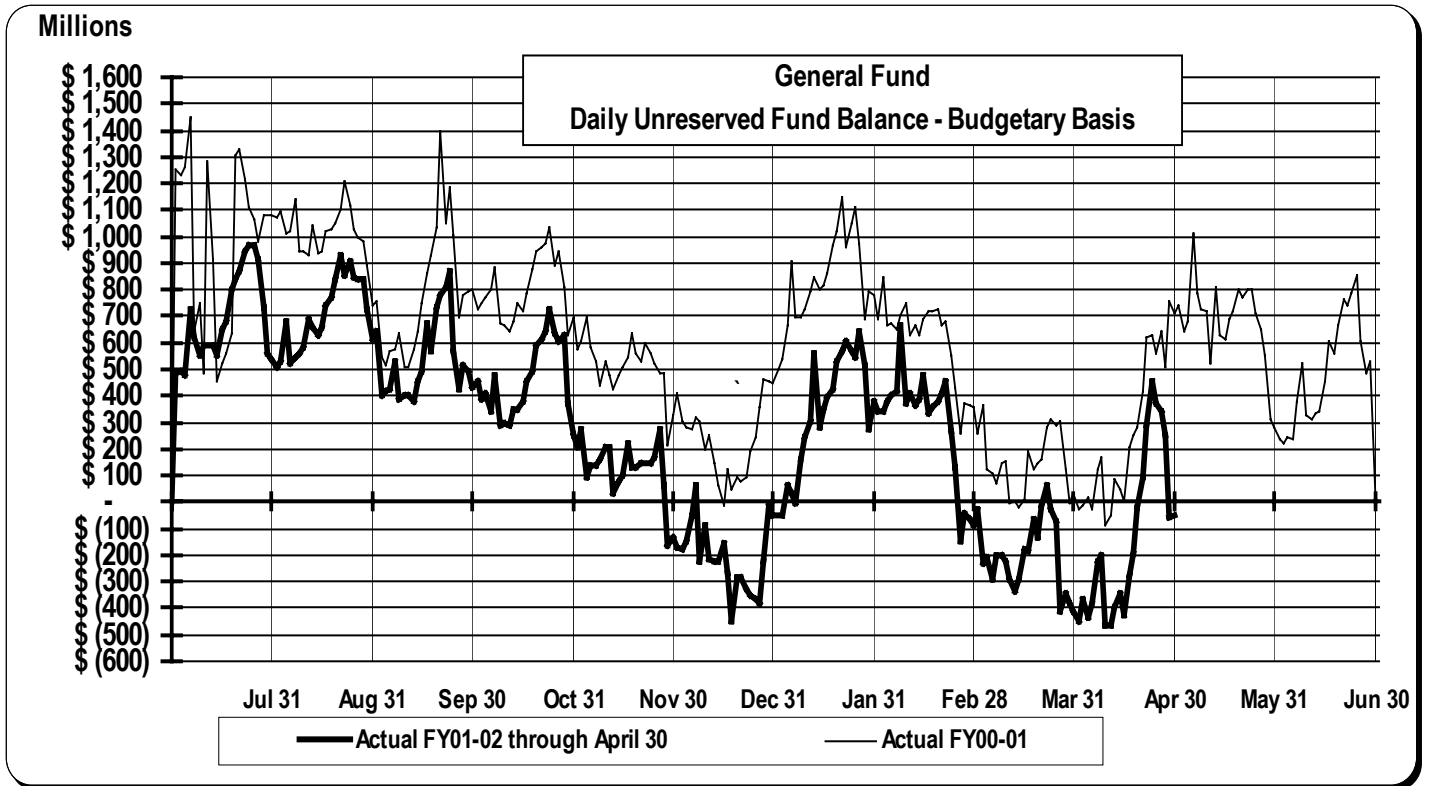

Note that the table represents net tax and non-tax collections and not gross collections. When compared to the prior year through April 30, actual tax and non-tax revenues decreased by \$128.7 million, or 1.1%. The net, or actual, tax and non-tax revenues through April 2002 of \$11,204.6 million were less than the projected revenues by \$1,173.5 million.

\$95.1 million for inventories reimbursement to local governments, not previously paid in April 2001, was repaid in July 2001 from the Governor Easley escrow fund (Executive Order #3).

Per Easley's Executive Order #19, issued February 5, certain funds are being escrowed to use if necessary to address the budget shortfall for the 2001-02 fiscal year. The additional revenue received under this order is reported as Other Non-Tax Revenue. Budgetary projections have not been revised to reflect this revenue. Through April 2002, \$80 million was transferred in from the Highway Trust fund and \$21.6 million transferred in from various other funds to possibly address the budget shortfall. If these additional dollars are not taken into account, actual revenues through April 2002 fall below projected revenues by \$1,275.1 million.

Major components of tax and non-tax revenues that increased from the prior year through the end of April 2002 included:

- \$187.7 million for Sales and Use Tax; and
- \$18.8 million for Insurance Tax.

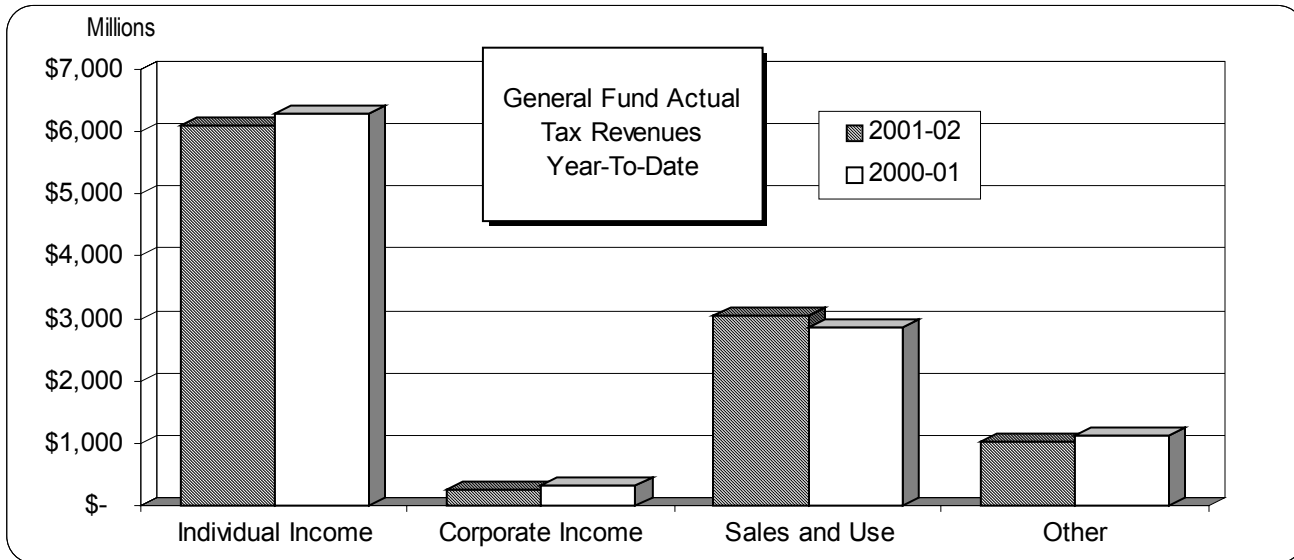

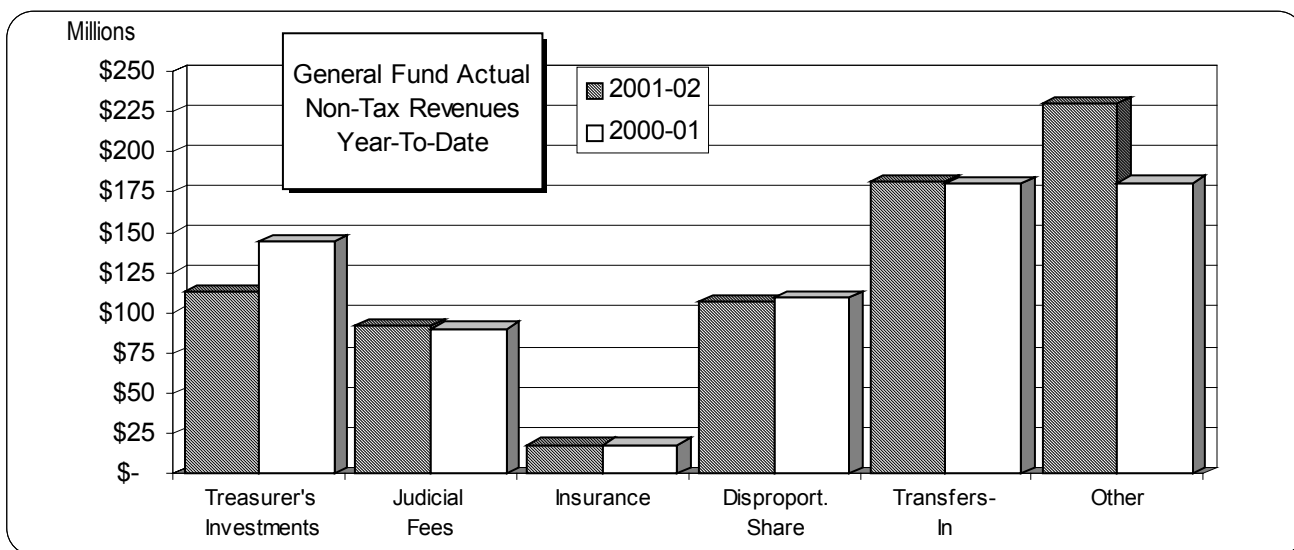

Tax revenues through April 2002 were less than the period through April 2001 by \$147.6 million, or 1.4%. Tax revenues are presented net of refunds to taxpayers and various transfers. Comparisons of current and prior year tax revenues are difficult due to legislative changes and netting of various transfer expenditures against the tax revenue sources. Examples of such transfers include:

- reimbursements to local governments;
- reimbursements for costs of administration of sales and use tax for local governments; and
- transfers to the Public School Building Capital Fund and Critical School Facility Needs Fund.



Non-tax revenue through the end of April 2002 was \$18.9 million, or 2.6%, greater than through the end of April 2001. Absent the \$80 million transfer from the Highway Trust fund, non-tax revenue would be down \$61.1 million, or 8.5%, from a year ago through April 30, 2002. Investment revenues decreased by \$31.5 million from the prior year through the end of April 2002.

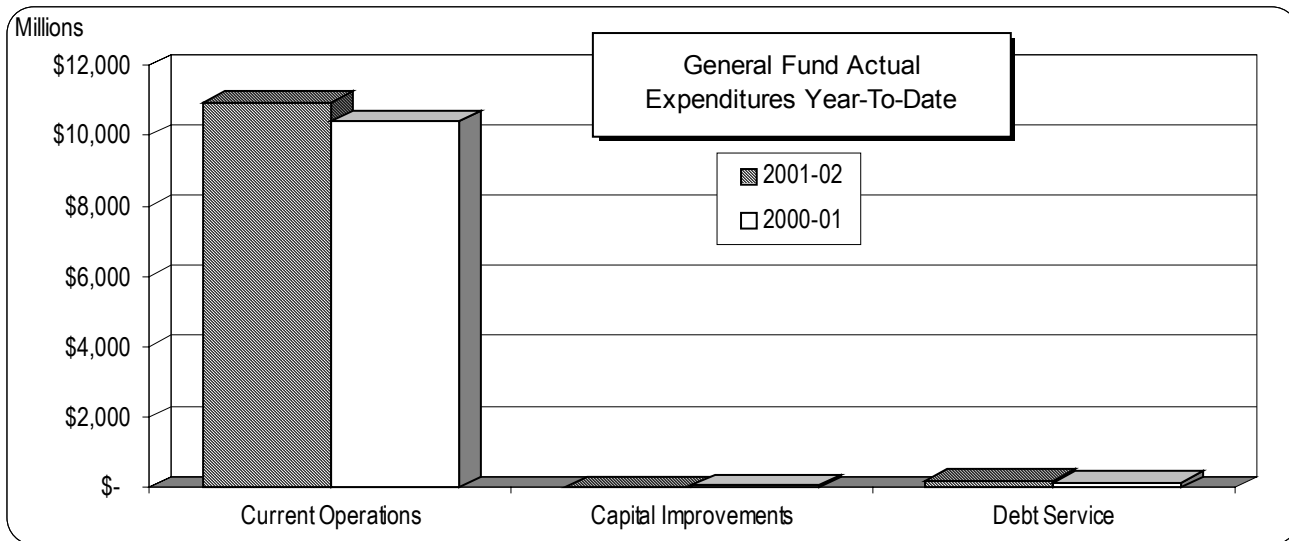

Expenditures

Actual appropriation expenditures through April 30, 2002, exclusive of appropriation expenditures for capital improvements funded by bond proceeds, were greater than actual appropriation expenditures through April 2001 by \$547.7 million, or 5.2%.



Expenditures for current operations (exclusive of expenditures for capital improvements and debt service) through April 2002 were greater than such expenditures through April 2001 by \$557.6 million, or 5.4%. Fiscal year 2000-01 General Government appropriation expenditures of \$(199.1) million include a disaster relief carryforward receipt of \$541.9 million.

General Obligation Debt - General Fund and Highway Fund

The following schedule presents principal payment requirements for the General Fund and the Highway Fund. This schedule is exclusive of defeased debt involving advance refundings where the proceeds were placed in an irrevocable trust with an escrow agent in an amount sufficient to provide for all future debt service payments on the refunded bonds. The amount of authorized, but unissued bonds was \$4.12 billion as of April 30, 2002.

The schedule below includes only bonds issued through April 30, 2002.
