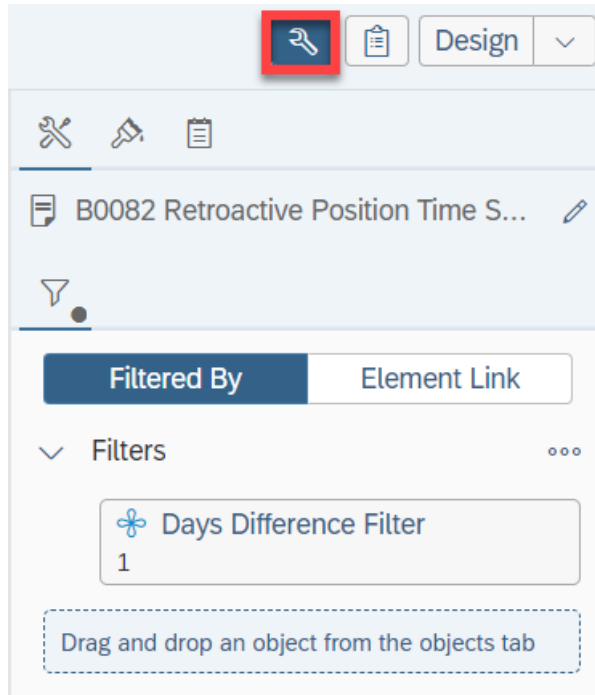

Special Report Considerations/Features

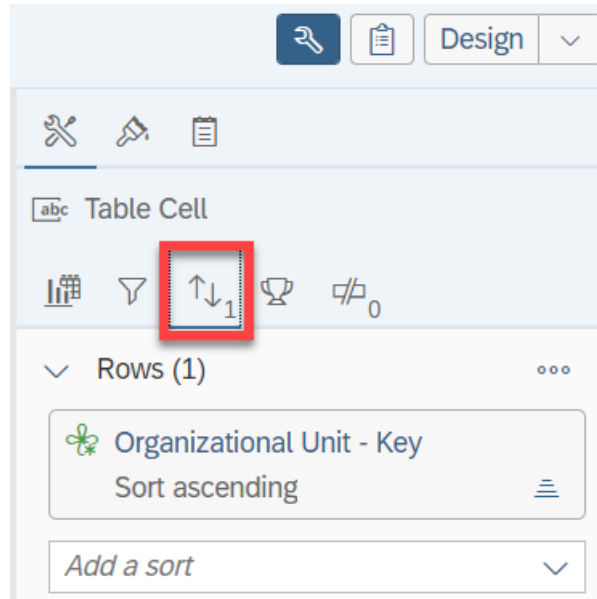
- There is a default filter applied to the report to calculate the Days Difference between Changed on and Effective from dates based on the Prompt Value entered in Min # Days Retro (Optional).
